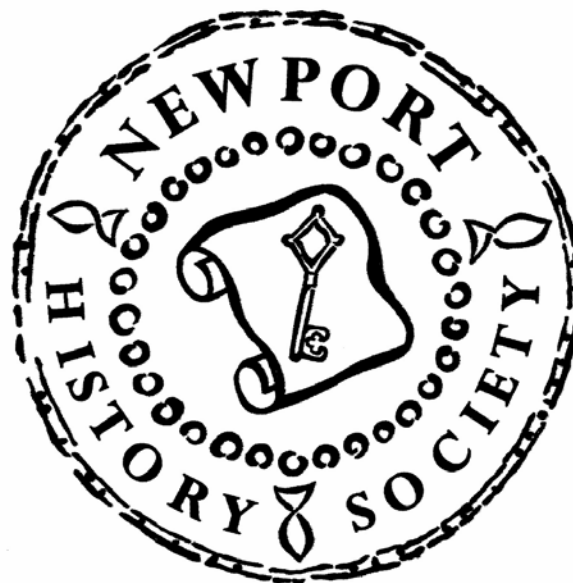


Newport History Society Meeting Venue
